

THE GENOCIDAL AGGRESSION Israel's Ongoing Atrocities in Gaza and the Complicity of Western Powers

The Gaza conflict between Israel Palestinian and factions. particularly Hamas, is a long and deep struggle, influenced by a web of complex historical, political, and regional motivations. The region, rooted in Israel's long-standing occupation of the Palestinian territories, has seen multiple tensions, each with disastrous consequences. The motivations behind the conflict range from Israel's security concerns and suppression of militant activity to Palestinian aspirations for selfgroups' determination and an end to the occupation. The recent war in Gaza has resulted in а catastrophic humanitarian crisis. resulting in massive civilian

casualties, destruction of and infrastructure mass displacement. The consequences are dire, including heavy losses on both sides, widespread trauma and a deep cycle of violence and reprisals. Furthermore, the conflict has further exacerbated tensions in the region, leading to increased international divisions.

Israel continues to bomb Gaza and carry out ground attacks. The Ministry of Health of Gaza says that more than 8,000 Palestinians have been martyred so far, including more than 4,000 children. More deaths are occurring as a result of the suffocating siege and blockade of Gaza, which many legal experts have called a war crime under

international law. After October 7, Israel completely blocked the entry of food, fuel, medicine, and other essential goods into Gaza. Although some aid trucks carrying food and medicine have been allowed to pass through the Rafah crossing with Egypt in recent days, Israel still does not allow fuel to enter the enclave, leaving hospitals with life-threatening conditions. Saving machines require electricity to operate. Despite growing calls for a ceasefire, Israel has said it will not stop attacks on Gaza until it destroys Hamas, which is controlled by Hezbollah, other Shiite armed groups in the region and their patron Iran. together form the socalled "axis of resistance". The





growing trend of war crimes by Israel, blatant violations of the international laws of war and the declaration of continuation of the war under the pretext of the complete elimination of Hamas can be well gauged by Israel's dangerous ambitions.

Israeli army hunting women and children in modern times

Gaza has a population of 2.3 million people living in an area of 365 square kilometers (140 sq mi), which equates to а population density of 6,300 people per square kilometer (16,320 people per square mile). According to the United Nations Office for the Coordination of Humanitarian Affairs (OCHA), children make up 47 percent of the population of Gaza. According to UNICEF, 4,104 children have been killed in Gaza in Israeli attacks during the current war. These deaths are due to violence that has been going on for more than a month. That means more

than 100 children are dying on average every day.

The number of children killed on a daily basis in the Gaza Strip is much higher than in Ukraine, Afghanistan, Iraq and other conflict zones. The international non-profit organization Save the Children has reported that the number of children killed in the three weeks of Israeli bombardment of the Gaza Strip up to late October is the highest in every year since 2019 in global conflict zones. More than the number of children killed annually. Since then, the number of small bodies wrapped in white shrouds and surrounded by grieving family members has increased as Israel has launched a ground offensive and increased artillery fire alongside its missile devastation. Is. Even a month after the war began, these figures do not fully reflect the extent to which Gaza's children have been killed. How do the killings compare to some other major conflicts in recent years? What is

happening in Gaza is clearly terrifying and devastating for all children.

The targeting of journalists by the Israeli army is a deliberate agenda to hide the truth and promote propaganda

It is said that "war without journalists is just a war of propaganda".

International organizations such as the Committee to Protect Journalists (CPJ) and Reporters Without Borders (RSF) estimate that at least 35 journalists and media workers have been killed since the war began. Most of them are local to Gaza. According to CPJ. the first three weeks of the war were the deadliest period for journalists covering the conflict since 1992, when the group first began tracking. А CPJ spokesperson explained in an email that "the deadliest period refers to the highest number of deaths in a given number of days." In this case, the brief 26-day period from the start of the war



on October 7, 2023. It is the longest time.

"We cannot ignore the level of journalistic casualties in Gaza," RSF Secretary General said Christophe Deloire. What happening is incredibly shocking. Israel, which is not one of the 123 member states under the ICC Treaty, says the court has no jurisdiction over the dispute. Israeli Defense the IDF told Reuters and the French news agency AFP that it could not guarantee the safety of journalists working in the Gaza Strip. targeting all military activities. We urge you to take all necessary measures to protect them. These events can give a good idea of the impure intentions of Israel in the days to come. Journalists should targeting know Heavy and international intimidation of media personnel is a deliberate plan to pave the way for propaganda to hide the truth and hide their war crimes from the eves of the world.

The targeting of women and children by the Israeli army is actually a heinous act of genocide

It is now becoming clear that Israel is carrying out a genocidal plan against the Palestinian population in Gaza. indiscriminately bombing more than 2 million Palestinians, half of whom are children, in Gaza during the past three weeks. The number of people who have died due to hunger and lack of medical facilities is countless. Thousands of innocent civilians have been martyred. Now this is a clear fact. Videos and photos documenting the violent killings, their fear and

desperation are readily available and being reported.

It is now becoming clear that Israel is involved in a genocidal campaign against the Palestinian population. Al-Jazeera's claim that Israel has relaxed its military rules and allowed its soldiers to conduct ground operations in the Gaza Strip is a major proof. It has given permission to kill any person. Israeli political figures and military officials openly discuss the idea of turning Gaza into eliminating rubble, the Palestinians, and Israeli settlers living on the land known as Gaza. Palestinians are deliberately deprived of the basic necessities of life such as food, water, shelter and medical care. Aerial bombs are causing massive damage and casualties. Israel is clearly carrying out the nefarious intent of genocide, which would be a unique example of cruelty in this advanced age and the so-called enlightened, human rights-loving, hypocritical Western imperialist world-system of the rest of the world. Role of Western Powers in Israel's Genocidal Plan

The horrifying reality of genocide is that it occurs with widespread support, either in the form of active participation (direct and indirect), or in the form of silent complicity. We have never seen a case of genocide openly and actively supported by so many characters. The majority of institutions in North America, Western Europe and elsewhere are either actively participating in this genocide of the Palestinians or are completely silent and thus indirectly involved. It should be noted that genocide requires two

In terms of material capabilities, the US empire has sent not one but two aircraft carriers to the region and has made it clear in words and actions that if any state or group tries to help the Palestinians avoid Israeli carnage If it tries, the US will intervene with its full force. Britain has also sent ships to support this Western imperialist threat to the peoples of the region. The US is sending military equipment and weapons to Israel and is refusing calls for a ceasefire or de-escalation. Corporations financial and institutions are providing financial support to Israel in the name of helping Israeli victims, as well as offering financial allegedly incentives to Egypt in an attempt to entice it to host Palestinian refugees. will not be allowed to re-enter the Gaza Strip. Years of American and Western aid and support to Israel have allowed Israel to develop infrastructure capabilities.

In terms of cover-up, the political, media, social and cultural institutions in the West are fully active in covering up and concealing the act of genocide and portraying it as a legitimate violence against oppressed Jews around the world. The Israeli operation is being framed as a mission to "eliminate Hamas", as opposed to what it actually is, the genocide of the Palestinian people and their elimination from the map. The few voices that question these narratives are



being marginalized, silenced, and disempowered. In essence, all the institutions of the West are currently fully and coordinatedly active in enabling the genocide of the Palestinians, all under the guise of protecting "civilization" from "barbarism."

Role of Western Media

Journalists have a responsibility to not only be impartial, factual and fair when covering war, but also to stand up against hatred and speak out against war crimes. They have a responsibility not to contribute to the dehumanization of entire peoples. By allowing a state to impose its PR narrative on its production, many in the Western media are failing the public and paving the way for more atrocities against Palestinians. Dozens of media and communication scholars have spoken out against unfair coverage. In an open letter, condemned the double he standard and the inflammatory used to language treat Palestinians as criminals. We have seen many times before. especially in the immediate aftermath of 9/11, what happens when leading media outlets in the West decide that the truth should not get in the way of the state narrative. Let us not repeat the disastrous mistakes of the past.

Role of the British Broadcasting Corporation

Research over the years has shown that the British media has long failed to present an accurate and unbiased view of the Israeli-Palestinian conflict and is clearly dominated by the mainstream Israeli narrative, causing Palestinians to Being ignored. Recent coverage of Israel's invasion of Gaza follows a similar pattern, emphasizing Israeli suffering and geopolitical motivations while ignoring the historical context of Palestinian oppression and occupation, thereby biasing the conflict. British media coverage of the ongoing war has failed to acknowledge the long history of Israeli oppression and land disputes, particularly ignoring the impact of decades of occupation on the Palestinians. This impression given by the media leads to dehumanizing and portraying illogically the Palestinians as deserving of the violence inflicted upon them.

The current situation clearly underlines the unwavering determination of the Western imperialist powers to maintain their historical through supremacy the use of lethal force. The ongoing crisis in Palestine is a clear example of the relentless pursuit of power and wealth that reflects this

imperial legacy. Pakistan's policy of forced refugee return has been widely criticized by United Nations agencies and human rights groups, and by the Taliban administration in Afghanistan, which insists that it is Pakistan was the only option. Yet EU countries resettled only 271 Afghan refugees in 2022. Afghan nationals have had to turn to a third country to apply for resettlement but are left damaged infrastructure. "We are actively reaching out and communicating with these individuals. Many of these groups would be at risk if sent back to Afghanistan.

Pakistan's foreign ministry spokeswoman Mumtaz Zahra Baloch said the groups would not be forced to return: "The fear of deportation of journalists, activists and minority groups is on our notice, and we will take appropriate precautions. Some

3,000 Afghan nationals who have been granted asylum in the UK are stuck in British-funded hotels in Islamabad that have been raided by Pakistani police.

According to United Nations data, about 1.3 lakh Afghan refugees who have Proof of Registration (POR) cards, and 880 thousand Afghan refugees have the legal right to stay in Pakistan, while according to the Interior Minister, 1.7 lakh 30 thousand Afghan refugees are living unregistered and illegally in Pakistan.

Acting Interior Minister Sarfraz Bugti said that if the West was so sensitive about Afghan refugees, it should have done more to relocate them in the two years since the fall of Kabul. We have set a deadline for the Afghans who are to be transferred to Western countries like USA, UK and other countries. If they are not taken to the West by the deadline, we must declare them illegal refugees, then detain them and

deport them. Refugee camps have been set up for thousands of people waiting to cross the voluntary border. More than 1,000 refugees are living in makeshift shelters in the Afghan border town of Chaman, anxiously awaiting deportation.

Bugti said: "There will be no compromise against illegal refugees. We have data on who is living illegally in Pakistan. We are going door-to-door, and we have done geo-fencing. "We will detain them and deport them. We have so far arrested dozens of people across the country, including the capital. We will take buses, trucks or whatever is available to take the Afghans to the border," Bugti said. It will be kept, and the authorities will trace them to ensure that they do not return.

On the other hand, refugees living in camps. Gul Mohammad, a 50year-old Afghan national, says he doesn't know what he will do in his home country as he has been living in Pakistan for many years with his family. I will see what I can do to survive in Afghanistan after I arrive.

Also in the camp was 23-year-old Mir Agha, who said: "I was born and brought up in Pakistan. All my siblings were born here. We had proof of refugee cards issued by UNHCR. But the police gave them scissors after arresting us. They said that Pakistan is not Afghanistan anymore, but our home and we will remain refugees there. We cannot belong there. are refugees in both We countries. I am worried. How will I live there and how will I stay there? Chaman District Deputy Commissioner Raja Athar Abbas said that the authorities had deported at least 4,000 people on Wednesday. For the refugees we are providing them housing, accommodation, food, medical and municipal services, and we have registered them with us before deporting them.



Now that due to the intervention of the Supreme Court and the possible pressure of political parties, once again general elections have been announced in the country. The Election Commission earlier gave the date of the last week of January but now February 8 has been fixed as the final date for the election. Perhaps this is the reason why there will be doubts about what will happen in February, even though the Chief Justice of the Supreme Court has asked us to have complete confidence and avoid creating doubts. However, there are other factors that are more likely to influence the final date of elections than the Election Commission and the dates given by it.

One of them is the return of former Prime Minister Mian Nawaz Sharif. By showing the popularity of the party leader in Punjab and beyond, PML-N organizing a lavish reception for him makes the election a reality. For this one incident has done more to restore the party's fortunes than any other statement.

The second, of course, is related to the economic situation. Elections may require international assistance. Perhaps it is no coincidence that the election date was announced at a time when the focus was on negotiations with the IMF for the second tranche of the SBA. With the election date now on the calendar, the clock has started ticking. Those setting the agenda for national decision-making these days must realize that they cannot ignore the deep political discontent brewing beneath the surface. Given the widespread mistrust between the state and the people, any attempt to force Pakistan's political future on its people is unlikely to succeed. Behind the cloak of control and management, the deep structural flaws in our politics, society and economy that have brought us to this point remain untouched. The country needs а credible leadership that can tackle this gap of challenges with popular support. On the other hand, our current decision-makers feel at



risk of losing their sense of relevance because of their modest success in stabilizing the economy.

It cannot be denied that a measure of economic stability has been achieved through targeted interventions in sensitive markets in recent months. It also appears the country is in a good position to approve the ongoing IMF review and receive the next tranche under its standby agreement with the lending agency. However, none of this should allow us to lose sight of the bigger picture. Given the current economic situation, Pakistan will have to а long-term financing sign agreement with the IMF within a few months. Any new agreement with the agency would reportedly conditional be on the establishment of a legally elected government in Islamabad, which would have a strong public mandate to implement deep reforms included in any future loan deal.

Given recent political developments, there is speculation that we could see a coalition government similar to the PDM-led setup that resigned in August. However, such an arrangement is unlikely to remain stable and will face obstacles. The only viable way forward is to hold free and fair elections to the satisfaction of the people. Doing so will place the onus on the political parties to develop and implement a transformational plan for the country. It is time for the state to remove itself from the picture altogether and let the politicians do their job. It can be that free, fair hoped and transparent elections will be ensured by avoiding political



experiments as necessary for national security and stability. And such a people's government can be established which has full confidence of financial institutions, domestic and foreign investors and people. So that the country can go on the path of development.

As the nation gears up for the upcoming elections on February 8, the confluence of factors, from the return of political heavyweights to the economic intricacies, paints a dynamic canvas for Pakistan's political future. The pivotal challenge lies

not just in setting the election date but in fostering an environment that ensures free, fair, and transparent elections. This moment calls for a departure from political experiments and a genuine embrace of the people's will. With the opportunity to elect a government with widespread public support, Pakistan stands at the crossroads of transformation. The hope is that the nation's leadership, once chosen through democratic means, will navigate the challenges with foresight, earning the confidence of both local and global stakeholders for a prosperous future.
